Weed Of The June Newsletter—Common Burdock (Wild Rhubarb)



- Common burdock is a biennial weed, reproducing by seed. Scout roadsides, ditches, waste areas, creek beds, pastures, and low lying areas for patches of this weed because it prefers moist fertile soils.
- Chemical Control - Amine 2-4D, Ester, Milestone, Tordon, just to name a few. Check your labels for rate and if your chemical you have on hand controls the plant.
- Seed viability - Varies up to 4 to 5 years.

Industry Update:

Industry News:

In this newsletter we will talk about a new bareground product from Bayer, **Plainview SC Herbicide**.

Bayer's new bareground product **Plainview SC Herbicide** was introduced into the market in 2020, Plainview SC Herbicide is a pre-mix of Esplanade 200 SC Herbicide, Method 240 SL Herbicide and Imazapyr Herbicide (Arsenal Herbicide). Many of you were already mixing these products together to get the bareground you needed, now it will be easier with less mixing and only needing 1 product to do the work of the 3 you have been mixing.

Use sites include but not necessarily limited to – roadsides around guardrails, delineators, road shoulders, railroad sites, industrial areas, utilities, airports, government and military installations, tank farms, pumping stations, storage areas, utility substations, lumberyards, around farm buildings, non-irrigation ditch banks, fence rows, manufacturing sites, parking lots, hardscape sites, and under asphalt or concrete as part of site preparation and other sites as listed where bareground (no vegetation) is wanted or required.

Use rates are 32 to 64 ounces per acre rates and not to exceed 64 ounces per acre per year, most common use rate is 3 pints per acre rate (48 ounces), watch applications around trees and shrubs as spraying around or over the root systems of these can severely damage or kill them, stay at least 2 driplines away from these (a dripline is the furthest branches of the trees and then double that for safety or, in the case of pine or spruce species or others stay at least the height of the tree away and possibly double that as well).

While this product would burndown smaller existing vegetation it is recommended that you add some glyphosate with it to help in controlling existing vegetation faster, non-ionic surfactant at a rate of .25% or 1 quart per 100 gallons of mix or MSO at .50% to 1% or 2 to 4 quarts per 100 gallons of mix are recommended as well.

This would be a good product for spraying in your equipment storage lots, for road shoulder recovery, around bridge rails, under guardrails and again many other types of sites for total vegetation control.

It is **not** recommended for use in any sensitive type of sites where bareground might be needed, watch applications on sloped areas or where any run-off might move towards any sensitive crops, trees or other non-target vegetation.

Update on DuraCor/TerraVue Herbicides:

While TerraVue Herbicide does have right-a-way labeling DuraCor Herbicide did not and CORTEVA has added a supplemental label for DuraCor that allows for spraying of right-a-ways and utility lines transecting grazed areas, there was a question posed to the North Dakota Department of Agriculture on this very supplemental label on broader spraying of right-a-ways and they think it could be used on right-a-ways, I would ask that you verify this with the North Dakota Department of Ag if planning on spraying right-a-ways with DuraCor Herbicide, you can contact Luke Wagner, Agriculture Pesticide Inspector Supervisor, ND Department of Agriculture at 1-701-328-4922 for any further clarity on this use for DuraCor Herbicide.
